## Mayor's message: Don't believe those who say, 'The sky is falling' Editor:

The "Letters to the Editor" that recently have appeared in local publications (Oct. 25) from Mr. Rendahl, Mr. Tozier, Mr. Rice and Mr. Siegel have inspired me to respond to their "sky is falling" mentality.

They continue to spread misinformation about the costs associated with our redevelopment efforts. Here is the truth: The vast majority of costs will be borne by the developer. The developer will purchase most of the property the City has acquired for the new town center. The City will keep some for parks and cultural/civic components.

The "back door" \$13-million loan referenced by Mr. Rendahl and seconded by Mr. Tozier came from a U.S. Housing and Urban Development award that includes a \$1.5 million grant and a low-interest \$13-million loan. It has not been "instigated" but is available to our City if and when we determine it should be utilized and paid for from our TIF (tax increment financing) funds, NOT from new taxes. Our elected officials have promised "No New Taxes" for redevelopment.

We expect to accrue tens of millions of dollars in TIF money in the coming years as development proceeds. Additionally, we have been awarded more than \$19 million in federal, state and county grants, low-interest loans and other funding for our share of the project, which is enthusiastically supported by our government partners. Moreover, as the development progresses, it will increase the City's tax base, further reducing the burden on homeowners.

We promise you this: We absolutely will not proceed with redevelopment without a concrete feasibility analysis. But don't you need a plan first, so that you know what you're assessing?

Mr. Tozier has consistently talked about our City "squandering funds," but he fails to mention the City has spent more than

\$200,000 in legal fees to defend against his

Mr. Tozier wrote that the City Council "attempted to give away a million-dollar asset" without regard for residents (a property he offered to buy from the City for \$450,000 in February). Actually, the Council offered to give five of nine acres for construction of a new Terrace Community Middle School, a school that is recognized as one of the best charter schools in the country. In short, we tried to answer Mr. Rendahl's question, when he wrote: 'Don't all of our children deserve the best education we can afford?"

I suggest that Mr. Rendahl visit Temple Terrace Elementary School, where he will see the most modern equipment available. Our City awards \$15,000 in grants annually to our schools to enhance education and provides youth swim teams, volleyball teams and golf teams access to our recreational facilities.

We also meet with our City's school principals every six weeks, and we are developing goals that will provide our children with the best education possible.

As for City services, we are constantly upgrading equipment and adding necessary personnel. We have added four new police officers and strengthened the Code Compliance Department. Our Department is internationally accredited. Our rails-to-trails project is slated for the 2008/2009 budget, and plans for a major renovation of the Lightfoot Recreation Center are now being prepared.

I realize that my letter is not "politically correct," but I owe it to our citizens to lay out the facts so that they do not have to rely on misinformation.

Those who say "the sky is falling" see only darkness. But for the rest of us, the City's future has never looked brighter. Joe Affronti
