Knapp, for City Council, here's a few Public

Record items submitted for your perusal:

—Mark has stated that he'd prefer that our redevelopment property be sold to a developer with the City maintaining control solely through the redevelopment code in place (no plan), yet Mr. Knapp recently refused to follow the same redevelopment code regarding his own property located adjacent to the redevelopment area.

—Mr. Knapp's building expertise (which does not include experience in mixed-use redevelopment) has been suggested as why we need him on City Council, but his experience is in building what we don't want built downtown, that is, more strip malls.

—Was Mr. Knapp's signing of a five-year office lease with two (2) five-year options in the La Beacon Plaza building in the city's best interests when he knew the city would soon be purchasing this building for the redevelopment, and thus be encumbered with substantial buy-out costs for his lease?

—Lastly, during his previous City Council tenure from Nov. 15 1994 through June 18 2002, Mr. Knapp missed a total of twenty-five (25) Regular Council Meetings and Work

Sessions, more meetings than the other Council members combined. During that same period, Fran Barford missed four (4) meetings as both Council member and Mayor.

Is this the level of dedication we desire?
