## Downtown plan at heart of council race

## **Temple Terrace City Council**

TEMPLE TERRACE - Voters will choose from a field of six candidates when they fill three seats on the Temple Terrace City Council Nov. 7.

Incumbents Ken Halloway, Linda Shattles and Glenda Venable hope to be re-elected.

Mark Knapp, Alison McGillivray Fernandez and Ken Tozier hope it's time for a change.

"I feel all the people on council currently are doing what they feel in their heart is in the best interest of the city," Knapp said. "But I disagree with their approach."

That approach has to do with the city's plan to transform the depressed southeast corner of 56th Street and Bullard Parkway into a neotraditional community. Its goal would be to provide a small-town environment where the city's 22,000 residents could work, live and shop.

Halloway said he had hoped the city would have made more progress on the plan by now.

"It's really the reason I ran for the council," Halloway said. "I want to help the city follow through."

Others say there are good reasons to move slowly on the project.

"We need to do it right, not throw it together," said Venable, acknowledging that many citizens are frustrated because the project is not coming to fruition as fast as they would like.

Shattles said the city's downtown revitalization plan is moving forward nicely but said "sometimes you have to drop back and punt."

Fernandez is in favor of the downtown revitalization but said the city should proceed with caution and not get caught up in too grand a plan.

"I think the redevelopment affects all of our property values," Fernandez said. "We need to be careful and not build something that doesn't suit our community."

Tozier said he is less concerned with the project's facade than with the services it would provide.

"It should be the type of redevelopment that provides things that are needed to run your household," Tozier said.

The top three vote-getters will be elected to fill the four-year council seats in this nonpartisan race.
